- o FDFFSACA Assess compliance with food safety programs (2 days)
- o FDFFSCHZA Identify, evaluate and control food safety hazards (1 days)
- o FDFFSCOMA Communicate and negotiate to conduct food safety hazards (1day)
- o FDFFSFSA Conduct food safety audits (1 days–to be completed in full workshop)

Purpose

It is part of the National Food Safety Qualification that is developed by the Agri-food Skills Council of Australia. These four auditing units are certified by RABQSA International and will give you the skills, knowledge and competencies required to conduct food safety audits in Australia. If you just require internal auditing skills and knowledge, you can just complete the first unit, Assess compliance with food safety programs in a 2 day workshop.

At the end of this 7 day training workshop, participants will be able to:

- o Understand food safety compliance and regulatory requirements
- o Identify, evaluate and control food safety hazards
- o Communicate, negotiate and develop food safety audit plans
- o Conduct internal and external food safety audits
- o Obtain RABQSA auditor certification.

This training program is designed for those who work in the food and food-related industry that require skills and knowledge to conduct internal and external food safety audits in a food establishment. It is designed to enable participants to have hands-on experience in preparing for and conducting a food safety audit and to audit external companies.
